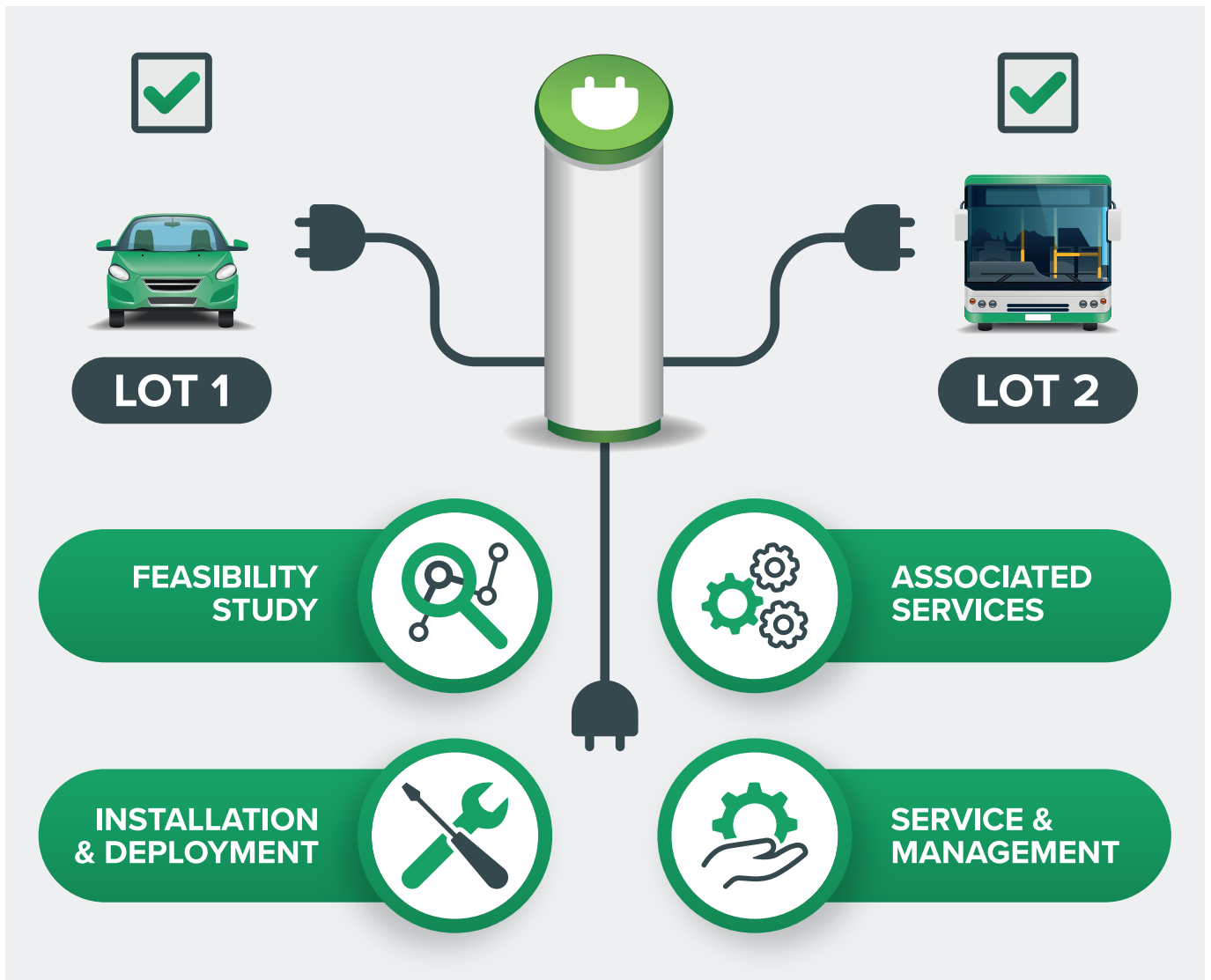

- ✓ The customer is satisfied that, following their own due diligence, they can identify the supplier that offers best value for their requirement.
- ✓ The supplier is able to supply the required goods/services within the customers timescales.
- ✓ The supplier scored the highest mark for price/quality in the Framework Agreement evaluation.
- ✓ Goods/services required are unique/exclusive to one vendor/supplier.
- ✓ Continuity of existing goods/services from an awarded supplier.

Are any of those boxes ticked by the customer? If yes, they can Direct Award without needing to do a Further Competition or get three quotes – it's as simple as that!

Please note, the customer only has to tick ONE

This is a regional framework in conjunction with KCC and will allow access to all public sector bodies, located within the SE7 (South East Seven) locations, which are: Brighton & Hove, East Sussex, Hampshire, Kent, Medway, Surrey, West Sussex.

The Framework Agreement is also open for use by all other local authorities and public sector bodies. Full details of the classification of potential Contracting Bodies and end user's geographical areas and organisation classifications can be found in the OJEU notice.
