KCC Highways Case Study

The Challenge.

We had the opportunity to speak with Lisa Tobin, Business Manager for Commercial Operations at KCC Highways, to gain deeper insight into their experience of our Vehicle Managed Service (VMS) solution:

As a Highway Authority, Kent County Council have the statutory responsibility to repair and maintain 8,500km of highway in a safe and fit for purpose condition for all users. We inspect, repair and maintain our highways to keep them safe and provide the best highway service we can for Kent's residents, visitors and businesses.

We started our VMS journey with Procurement Services around six years ago, before this we managed our fleet in-house which was quite challenging due to us having over 190 vehicles and over 500 drivers in our fleet.

The Solution.

KCC wanted consistent fleet management arrangements across the county, where an appropriate supplier was sought to deliver a dedicated Fleet Management service. 
Our VMS package was tailored to meet our unique requirements, including vehicle acquisition, booking arrangements, service management, fuel card management, management reports, telematics provision and 5-year vehicle lease contracts.

We have procured leasing and telematics contracts for cars and vans. In particular this includes Renault Cleo hybrid vehicles, Toyota Corolla, Ford transit customs and VW caddies.
