

Workplace illness & injury statistics

Illness - **1.8 million** people who worked during the last year were suffering from an illness they believed was caused or made worse by their work (2021/22)

Working days lost – **36.8 million** days were lost due to work-related ill health or injury

Injuries – 123 workers were killed at work (2021/22)

RIDDOR reported injuries at work 61,713 employees (2021/22) Cost to Britain - Injuries and new cases of ill health resulting largely from current working conditions cost society an estimated £18.8 billion in 2019/20

Health Surveillance



Health Surveillance Ongoing systemic health assessments designed to detect and monitor work related ill health

Health surveillance is a system of ongoing health checks designed to detect and monitor signs of employees work related ill health, these health checks may be required by law for employees, operatives, agency staff or subcontractors who are exposed to:

Lung Function Testing (spirometry) - Control of Substances Hazardous to Health Regulations (2002)

Skin Surveillance - Control of Substances Hazardous to Health Regulations (2002)

An on-site service for skin checks, our skin checking service is very convenient, simple and causes minimal disruption with the medical review only taking 10 minutes per employee.



Hand Arm Vibration Syndrome - Control of Vibration at Work Regulations (2005)

- Tier 1 & 2 questionnaire assessments

Medicals

An examination to assess a person's state of physical health or fitness for work

KML Occupational Health provides medicals which reflect and support your business including any specific set of requirements. We already provide industry approved and recognised medicals. In addition to these medicals we can accommodate any new requirements and provide a medical to include a series of assessments for your compliance.

Safety Critical Worker

KML OH defines a Safety Critical activity as one which poses an immediate risk to an individual or an immediate risk to others around them.

A Safety critical worker medical includes monitoring with a repeat medical delivered again every 3 years or when risk assessment, circumstances change and dependant on age of the individual.

Assessments: Pre-assessment questionnaire, Audiometry (hearing test), Spirometry (lung function test), Skin, Urinalysis, Visual Acuity – including colour / vison screen, Height, Weight and Body Mass Index (BMI), Blood pressure, Musculoskeletal assessment and Resilience (non physical health).



Network Rail

KML OH is a registered and approved Network Rail supplier for medical assessments and Alcohol & Drug screening. KML OH is RISQS accredited through Audit.

Competency Specific Medical formally known as a, Personal Track Safety Medical (PTS) - KML OH will deliver the medical, upload results onto Sentinel and record elsewhere appropriately in accordance with procedures.

Assessments: Pre-assessment questionnaire, Audiometry (hearing test), Visual Acuity – including colour, Urinalysis, Height, Weight and Body Mass Index (BMI), Blood pressure, General Health, Lifestyle, Psychological Wellbeing, Musculoskeletal Assessment, Alcohol & Drug screening (optional).

Corporate

KML OH can provide executive and non-executive medicals which reflect your business needs. This can include assessments such as display screen equipment (DSE), lifestyle, and general health screening, to more comprehensive health checks for example diabetes and cholesterol tests, ECG, musculoskeletal and other assessments.

All our medicals come with feedback and advice; this data can be reviewed and presented anonymised for trend analysis to best help any business take the appropriate action.

Do you know YOUR numbers?

"Know your numbers" is a mini health check. It is a quick assessment that aims to help employees gain knowledge of key health statistics and encourage awareness about common physical wellbeing concerns.

The assessment is 20 minutes long and it is carried out by our Occupational Health Technicians. Employees can attend our clinics (Esher, Surrey and Thames Road, Silvertown) to have this assessment done or we can attend employee's workplace.

The checks within the assessment are as follows:

- Meight, Weight and BMI

An occupational health assessment is an independent clinical assessment performed by an occupational health professional providing the employer with an opinion on an employee's fitness for work with any adjustments which should be considered.

KML OH will work with you to ensure that our OH team have a robust understanding of your employee's roles and responsibilities and your scope for accommodating any sickness absence or capability concerns.

Employee's must consent to this service and be made aware of the purpose of the occupational health referral.

Fitness for Work An assessment to identify if you are fit for work and to carry out a specific task/s against your job role

Fitness for work can mean a culmination of assessments to achieve a desired outcome and typically a fitness for work certificate is produced for individual records.

Drug & Alcohol Screening



Drug & Alcohol Screening A two part screening process for the workplace to identify the misuse of drugs and alcohol

The misuse of drugs and alcohol is a serious problem in the workplace, not only for the misusers but also for employers, colleagues and the public.

The possession of some drugs is illegal; other prescribed drugs and over-the-counter medicines can also have side effects which could affect safety.

Testing for drugs and alcohol has been mandatory in the Railway Industry for some years and many Construction companies already undertake drug and alcohol testing to ensure that workers are safe to work on sites and to protect members of the public from accidents due to misuse of drugs and alcohol.

Alcohol or drug problems should always be treated primarily as a health problem rather than a reason for immediate dismissal. Employers should encourage employees who show signs of developing such problems to seek help.

KML OH provides the following drug & alcohol screening services outlined below:

- Point of care testing onsite results within 5 minutes, POCT cups substance screening type & cut off levels tailored to the needs of the business
- Chain of custody a chronological documentation or paper trail, showing the collection, transfer, receipt, analysis, storage, and disposal of the sample
